Item	Amendment/Revision
1	The Bids and Awards Committee instructs bidders to submit bid prices in accordance with the rates prescribed in the latest DOLE Wage Orders.
2	Computation of mandatory government contributions such as SSS, Pag-ibig Fund, Retirement Fund, PhilHealth Contribution, etc. shall also be based on the basic wage rate and shall be in compliance with applicable laws and regulations.
3	Bidders are also instructed to follow applicable DOLE Orders and guidelines governing employment and working conditions of security guards and security personnel.
4	In the event that two or more bidders are declared LCRB after the bidders have been post-qualified, the Bids and Awards Committee shall follow a non-discretionary and non-discriminatory method which is by means of "draw lots" in order to resolve cases involving a tie.

All conditions, and instructions to bidders specified in the Invitation to Bid, Bid Data Sheet, Terms of Reference and all other instructions and items in the Bidding Documents inconsistent with this Bid Bulletin are hereby superseded, modified and amended accordingly.
